- Scholarship endowment
- Review of statement of financial position
- Unknown attendee: Asked what we usually give to the scholarship
 - Answer: We generally used to give \$1,000, then bumped it up to \$3,000.
 Now we budget for \$1,000 for the CCRA scholarship. Anything else we want to give to we will look at on an annual basis
- Annete Protain: Noted she does not remember receiving anything asking for a
 donation to the scholarship. Has not been asked to support specific activities by
 the College. Is not opposed to this and would want to do this given the
 opportunity
 - Answer: Donations can also be done on individual basis. The Office of Development does have a mailing list but we do very little solicitation by mail for the College; we do mostly digital fundraising. If you'd like to receive fundraising communications, we are happy to take your email address and keep you up to date
- Debbie Cameron: Asked if there is any chance to increase the scholarship amount of \$1,000
 - Answer: When we give extra, we give to the Giving Tuesday initiative. The funds are matched. Giving Tuesday also supports student scholarships and this support is given in addition to the CCRA scholarship
